Opening Business:

President and Co-Chair Dan Brin called the meeting to order at 6:35 p.m. Secretary Nicole Flessati called roll and announced an initial attendance of 19 board members, meeting the requirements of a quorum. The April 1, 2014 meeting minutes were approved without changes.

Comments from the chair:

Mr. Brin announced that ALL WHNC board members have taken and passed their Ethics and Funding trainings. He also announced that Citrus Sunday is May 18 and the first West Hills Memorial Day Weekend 5K and 10K Run/Walk will take place on May 24, when he will be among the runners. Dan thanked Ed Young for all his hard work on arranging the run.

Ed Young commented that there were 178 people already registered to run on May 24 and he expects 100% of the board to participate in some way.

Also announced was the neighborhood clean-up of Saticoy and Ingomar Streets between Woodlake and March Avenues on May 17, 2014. Volunteers and weed-whackers are needed for the day.

Mr. Brin also urged board members to join him in purchasing tickets for the 2014 Gala of the Canoga Park/West Hills Chamber of Commerce on May 16 and to participate in West Hills' entry in Canoga Park's Memorial Day Parade on May 26.

Public Comment:

Stakeholder Chris Rowe read from a letter she received from NASA regarding the Santa Susana Field Lab. NASA says there will be 316 trucks per day going through West Hills during the proposed clean-up of the SSFL site. She cited concerns of increased traffic accidents and spills, which would reduce the net benefits of the clean-up.

LAPD Senior Lead Officer Brent Rygh urged attendees to lock their cars and hide their bags and valuables. He said vehicle theft is way up with at least 20 this last week, 70% of which are from unlocked vehicles. Thieves check the door handles.

New Business:

Agenda Item 14-0031 - Discussion and possible actions regarding appointments to fill vacancies on the West Hills Neighborhood Council Board

Five candidates filed applications for two open seats. Candidates are as follows:

Margery Brown – recent member of the WHNC Board Esperanza Butler – local Realtor and resident Mark Graff – teacher at Pomelo Elementary Carolyn Greenwood – recent member of the WHNC Board Edwin Monteagudo – Director, L.A. County Probation Dept.

Each candidate had two minutes to present themselves to the board. Then the members of the board voted on two of the five candidates.

Before the vote, Charlene Rothstein, as chair of the Ad Hoc Board Vacancy Committee, announced the committee's recommendation of Margery Brown, Carolyn Greenwood and Esperanza Butler.

Margery Brown and Carolyn Greenwood were selected to rejoin the Board. A tally of the votes is attached to these minutes.

Due to the elections on June 3, the scheduled monthly board meeting on June 3 presents a scheduling conflict to Ms. Yvanek-Garb as she works as an election inspector. Dan Brin suggested moving the June WHNC meeting to a different night. If the meeting can be rescheduled, then a leave of absence will become moot.
