# FINAL MEETING MINUTES February 2, 2017

### **OPENING BUSINESS:**

President and Co-Chair Dan Brin called the meeting to order at 7:05 p.m. Secretary Carolyn Greenwood called roll. Co-Chair Charlene Rothstein led the Pledge of Allegiance.

Minutes of January 5, 2017, were approved.

**Agenda Item 17-0012** – Discussion and possible action regarding the approval of the WHNC's December 2016 Monthly Expenditure Report ("MER")

December 2016 MER was approved with 23 ayes, 0 noes and 2 absent.

### **COMMENTS FROM THE CHAIR**

Dan Brin stated that Chaminade has agreed to accommodate all of our committee meetings in the large upstairs room in the Condon Center. The Education and the Public Health Committees will continue to meet at Pomelo Elementary and the Zoning & Planning Committee will continue to meet at Fairwinds.

Mr. Brin was asked the reason for the presence of a Cub Scout troop just before the meeting. Mr. Brin explained that the troop leader had asked if they could come and if he would explain about the purpose and activities of the neighborhood council.

Mr. Brin reminded everyone about the Measure S Town Hall Meeting on Tuesday, Feb. 7, 2017 in El Camino Real Charter High School's multipurpose room. Several members have been working hard on this cooperative effort with the West Valley-Warner Center Chamber of Commerce, Canoga Park Neighborhood Council, Woodland Hills-Warner Center Neighborhood Council, Canoga Park/West Hills Chamber of Commerce and our own council.

### **ANNOUNCEMENTS**

Janis Risch, director of the Los Angeles Library Adult Literacy Program, gave an overview of the program and encouraged all to participate. Ms. Risch can be contacted at the Platt Library.

Mr. Ron Rubine, District Director from CD 12, wanted a round of applause for board members Simone Best, Tom Booth and Joan Trent for spearheading the recent homeless count event.

Mr. Rubine gave an update on a couple of other issues: That the meeting on reopening the Aliso Canyon gas storage facility got so raucous that it was shut down during public comment and Assemblyman Henry Stern is introducing a bill, AB 146, requiring that Southern California Gas Co. be held accountable for determining exactly what went wrong before it reopens the site. With regards to the Haynes Street Bridge – the Bureau of Engineering has completed its review and has reached out for input from LAUSD, LAPD and the Fire Department. The LAPD came back with several issues that are being reviewed.

Lastly, Mr. Rubine advised that Councilman Englander is holding the first of a quarterly CD12 Speaker Series on Thursday, February 9, 2017, with a round table with two Holocaust survivors, Gabriella Karin and Robert Geminder.

Senior Lead Officer Kari McNamee gave an update on current crime statistics in West Hills. Residents need to stay vigilant, as property crime and burglaries have increased. To help in this area, there will be a Property Crime Unit in the Division. Officer McNamee said the LAPD will be able to enforce the new regulations for vehicles used as dwellings starting Feb. 6.

### **PUBLIC COMMENT**

Ms. Samantha Stevens stated she was here to speak about Measure M on the March 7 ballot. Measure M proposes to give the residents of Los Angeles a voice in writing the rules and safeguards to regulate, control and tax the legal sale of marijuana in L.A.

### **CERTIFICATE OF APPRECIATION**

Certificates of appreciation were presented to Bonnie Klea for her work on behalf of the workers at Santa Susana Field Laboratory, Justice Street Volunteers for their hard work in the beautification of West Hills, and three Pierce College students for their efforts in completing the homeless count.

Community/Senior Center Committee – Working with LAUSD to select a potential location for the community/senior/cultural center.

## Bylaws and Standing Rules amendments for discussion and possible action, Tuesday, Sept. 6, 2016

### **Bylaws amendment:**

Section 6: Vacancies on the Board shall be filled using the following procedure:

- A. When a vacancy is created on the Board, a notice shall be posted immediately on the WHNC website and by posting a notice in a public place, by sending an email via the WHNC email list, *publishing a notice in social media*, and by announcing it at the next *regular* board meeting.
- B. Procedures shall be defined in the West Hills Standing Rules.

B. Any qualified Stakeholder interested in filling a vacant seat on the Board shall submit an application to the Secretary within 30 days after posting of the vacancy. Such application forms may be available on the WHNC website or may be obtained by written request to the secretary of the WHNC.

C. The Secretary shall immediately transmit the application to the Chair of a designated committee for review and action.

D. The designated committee shall meet within 15 days of the filing deadline. The committee shall review the applications to ensure that the applicants are eligible to hold the office and are otherwise qualified to undertake the level of participation expected of Directors of the Board of the WHNC.

E. The committee shall submit all applications and shall make a recommendation of a qualified candidate to the President within ten (10) business days of its decision. The President shall have the filling of the vacancy placed on the agenda for a vote at the next Board meeting.

F. All applicants shall be required to speak to the Board in conjunction with their application. Then votes of the Board shall be taken and the seat shall be filled by a vote of a simple majority.

G. When the aforementioned process fills a vacant seat, that seat shall be filled for the remainder of the term for that seat.

**Bylaws Amendment** 

ARTICLE VII COMMITTEES AND THEIR DUTIES, Section 2: Committee Creation and Authorization
The Board shall establish all Standing Committees and the President shall establish Ad Hoc Committees
as needed to address temporary issues. Suggestions for committees may come from Stakeholders or
from members of the Board.

B. All committees shall present copies of their approved minutes, <u>agendas, and/</u>or reports for designated posting as defined in the West Hills Standing Rules.

C.—All standing committees shall publish agendas and post meeting notices
