OPENING BUSINESS:

President and Co-Chair Dan Brin called the meeting to order at 7:05 p.m. Secretary Carolyn Greenwood called roll and established **quorum.**

Approval of Board Meeting Minutes of February 6, 2020 were approved as amended.

Special Meeting Minutes of February 20, 2020 were tabled.

20-0040 – Discussion and possible action regarding approval of the WHNC's January 2020 Monthly Expenditure Report (MER)

Board member Anthony Brosamle questioned what was expenditure to vendor Total Event in the amount of \$210 was for. After some discussion, it was stated that this expenditure was for insurance for the Senior Valentine Dance.

January 2020 MER approved with 18 yes votes, two (2) abstentions, three (3) absent and two (2) ineligible.

Treasurer Bob Brostoff stated that the first go around in preparation for the 2020-2021 budget year will begin at the April Budget Committee meeting.

COMMENTS FROM THE CHAIR:

Mr. Dan Brin stated that we held a magnificent Senior Valentine Dance. He also said that we can take a breath after a stressful election season and before the November elections.

PUBLIC COMMENT:

Jessica Isabel Irias Discua spoke to thank the WHNC Board for having the CERT training. She has wanted to take this training for a long time.

ANNOUNCEMENTS:

Senior Lead Officer (SLO) Kari McNamee gave an update on the crime statistics for West Hills. Although reported crimes are down there was a very unusual crime in the area, an attempted rape. Officer McNamee again reminded everyone to lock their cars and not leave valuables inside.

Nikki Perez, Field Representative for Assemblymember Jesse Gabriel, reviewed the types of legislation the Assemblymember is considering.

Eric Moody, District Director for Councilmember John Lee, stated that the councilman has introduced a motion to transfer additional funding to the Topanga Station for additional police services.

7:45 p.m. Board member Bill Rose left.

Semee Park, Department of Neighborhood Empowerment, announced there are a lot of changes in the City Clerk's office regarding vendors. More information will be available soon. There is an ethics training on March 16 in Van Nuys. Board of Neighborhood Commissioners (BONC) has passed language for censure and removal of a board member. Final language is not available at this time.

Tessa Charnofsky, District Director for Supervisor Sheila Kuehl's office, spoke about the problems that occurred in the March 3 election. Ms. Charnofsky stated that the supervisor has said there will be reforms and improvements by the November election. The census is starting next week and she requested that everyone respond. She advised that the supervisor has discretionary funds available to nonprofits. The deadline to apply for funds is April 1.

Tara Vahdani, Administrative Assistant to Board Member Scott Schmerelson, advised that they are recruiting for the next student board member. Also there will be a "College Palooza" on March 21 at L.A. Trade Tech College where college and career experts and educators will be available.

COUNCIL ANNOUNCEMENTS:

Environment Committee – Meeting is next Wednesday, March 11, at 7 p.m. Two managers from DTSC will be present to discuss the SSFL cleanup.

A reminder – Spring Fest is March 21.

Zoning & Planning – The lot split at 6510 Capistrano Ave., West Hills is on the agenda. The Zoning Administrator gave everyone until March 14 to submit recommendations, as many residents who attended the hearing last week said they did not get proper notice.

OLD BUSINESS:

20-0029 – Discussion and possible action on letter to CD 12 requesting Pilot Safe Parking Sites

Harry Sherman spoke about safe parking. He is with the West Valley Neighborhood Alliance on Homelessness and has been involved for three years. He provided background and information on Safe Parking, particularly the one behind Councilmember Bob Blumenfeld's office. WHNC Board Member Brosamle raised several objections to the letter and stated there needs to be a forum so residents could express their opinions. Mr.

Brosamle stated it is inappropriate to send a letter until we hear from the residents and this meeting does not qualify as a forum.

There was more discussion and a friendly amendment to hold a forum within 30 days was suggested but was not seconded. The motion to send the letter as written passed with 12 yes votes, five (5) no votes, four (4) abstentions and four (4) absent.

NEW BUSINESS:

20-0041– Discussion and possible action regarding changes to the El Camino Real north campus CUP at 7401 Shoup Avenue in West Hills.

Mr. R. (Nic) Nicolas Brown, Consultant with Pacific Crest Consultants, stated that the property was acquired by El Camino's Independent Study facility. Independent Study is for students that are in good standing academically but for various reasons cannot attend school regularly. The students are required to come to the campus once a week to meet with the teachers.

After some discussion on how El Camino has incorporated suggestions both from the WHNC Board and residents and their efforts to reach out to the residents, the recommendation to approve the CUP passed with 20 yes votes, one (1) abstention and four (4) absent.

20-0042 – Discussion and possible action on reimbursing Bob Brostoff in the amount of \$29.34 from Ralphs Market for the February Board meeting refreshments. Line Item 1

Board Member Faye Barta pointed out that, per the receipt in the packet, the amount should be \$27.34.

Recommendation to reimburse Bob Brostoff in the amount of \$27.34 passed with 19 yes votes, four (4) absent and two (2) ineligible.

20-0043 – Discussion and possible action on approving a Spending Request for decorating three Utility Boxes for up to \$800.00.

Streets and Transportation Committee Chair Olivia Naturman stated that the funds are for the materials to paint the boxes. Two of the artists who volunteered to paint the boxes, Merrilyn Duzy and Iris Peretz, were present and presented renderings for consideration. A third artist, Aida Abkarians, a member of the WHNC Board, withdrew because of a possible conflict of interest. Ms. Naturman stated first we need approval of the expenditure and then the Board would decide on the design.

The recommendation to approve a Spending Request for decorating three Utility Boxes for up to \$800 passed with 18 yes votes, one (1) no vote, four (4) absent and two (2) ineligible.

20-0044 – Discussion and possible action on approving a Spending Request for Safety Fair Expenditures in the amount of \$800.00.

It was pointed out that this was a typo and the actual amount requested is \$1,800. The safety fair will be held on May 16 to promote bike and pedestrian safety.

Recommendation to approve Spending Request for Safety Fair in the amount of \$1,800 passed with 19 yes votes, four (4) absent and two (2) ineligible.

20-0045 – Discussion and possible action on an Event Approval Request for the Safety Fair Recommendation to approve Event Approval Request for the Safety Fair passed with 19 yes votes, four (4) absent and two (2) ineligible.

Co-chair Dan Brin stated that the request was incomplete and submission of an Event Approval form could not take place at this time. However, we will do a preliminary vote on having such an event. **The preliminary vote on having such an event was 19 yes votes.**
