Chair Dan Brin called the meeting to order at 7:04 PM.

Secretary Brad Vanderhoof called roll and established quorum.

Vice President Char Rothstein led the Pledge of Allegiance.

The minutes from the August 2020 meeting were approved as amended.

20-0086 - Discussion and possible action regarding approval of the WHNC's July 2020 Monthly Expenditure Reports (MERs).

Controller's Report: Saif Mogri said a couple of invoices, The Web Corner and Rackspace, were paid in August.

Budget Report: None

Chair Comments:

Dan said we will all miss Board member Bobbi Trantafello who passed away recently. Bobbi was an original WHNC Board member. She also served the community with the West Valley Playhouse, Canoga Park Neighborhood Council, Canoga Park-West Hills Chamber of Commerce, and the Cinema Heritage Project. Bill Rose is working on arranging a memorial service at West Valley Christian Church. **Her Board seat is declared vacant.**

Zach Volet has resigned from the Board. His seat is declared vacant.

Ann Mizrahi has resigned from the Board. Ann thanked everyone for the opportunity and said she took great pride in serving the community. **Her seat is declared vacant.**

Public Comment:

Dave Brown spoke about the 13th Annual Valley Disaster Fair. The online event is Saturday, Oct. 10, 2020 from 9 a.m. to 1 p.m. Registration is open now at www.valleydisasterfair.com. The virtual event will feature three streams: speakers, exhibitors and interactive training. Founding member Bill Hopkins passed away and the fair has been renamed the Bill and Linda Hopkins Valley Preparedness Fair. A scholarship for amateur radio was established. The fair organizers have asked Neighborhood Councils to send a paragraph of welcome to their stakeholders, submit a five-minute video, and suggest a point of distribution for the emergency kits.

Gail, an East Valley resident, is opposed to closing the West Valley Animal Shelter.

Marilyn Koziatek, candidate for LAUSD School Board District 3, introduced herself.

#650 was a volunteer at the West Valley Animal Shelter for many years and is opposed to the hybrid shelter plan.

Michelle Cornelvis, a 13-year volunteer at the West Valley Animal Shelter, wants the shelter to stay a municipal shelter. She asked the WHNC to file a CIS on CF 20-1114.

#411 said the West Valley Animal Shelter is the only air-conditioned shelter in the SFV and should not be closed.

#551 is a Porter Ranch resident and a 15-year volunteer at West Valley Animal Shelter. She is opposed to the hybrid shelter plan.

Board member Olivia Naturman said the public comment period to L.A. City Council is still open.

Announcements:

Betty Wong Oyama, Neighborhood Empowerment Advocate, offered condolences for Bobbi Trantafello. The City Council approved a vote-by-mail plan for Neighborhood Councils' 2021 elections. Feedback from NCs is due Sept. 8. There are meetings to discuss homeless election participation on Sept.14 and 30. CF 20-0990 concerns increasing the mandatory training requirements for NC members. NCs are now allowed one optional youth seat. There is a new community stakeholder definition: member of a participating organization that benefits the community. All NC bylaws will be updated by DONE. A digital webinar will be held Wednesday, Sept. 30, from 5 to 6 p.m.

Eric Moody, district director for CD12, offered condolences for Bobbi Trantafello. CD12 has a NW SFV lunch program. Councilmember John Lee, CD12, has introduced a motion to have Animal Services submit a plan to reopen the West Valley Animal Shelter. CD12 is asking for suggested locations for the bridge housing requested in a letter approved by the WHNC.

Tessa Charnofsky, representing Supervisor Kuehl's office, said a new health order allows hair salons to open for indoor service at 25% capacity. Voting centers will be open for five days for the November election. There is a 17-day window for mailed ballots to be received.

Patricia Bates, Budget Advocate for Region 3, gave an update. Reporting will be based on issues instead of city departments. They are asking for a dedicated ranger station in the Sepulveda Basin. Dan Brin added Joanne Yvanek-Garb and Joan Trent are the WHNC budget reps.

Thomas Booth said a cooling center will be open this weekend, Friday to Monday, from noon to 8 p.m. at the Canoga Park Senior Center, 7326 Jordan Ave.

Secretary Brad Vanderhoof called roll and established quorum.

Vice President Char Rothstein led the Pledge of Allegiance.

The minutes from the July meeting were approved.

Controller's Report: Saif Mogri said a couple of invoices for Web Corner and Rackspace were paid in July.

Budget Report: None

Chair Comments:

The Chairs stated they are both working to handle the discord on the Board and need to keep the Council functioning. Board members' number one priority should be to behave in a civil manner and work together.

Public Comment:

Marie Javdani is worried about the low census count, especially among seniors. Barbara said the West Valley Animal Shelter is currently closed and she is concerned there will not be services available if it becomes a private rescue center. Gail said with the shelter closed the only animal services in the San Fernando Valley will be at the East Valley shelter and CD12 has provided no comment. Michelle is opposed to giving the shelter to a private rescue organization. "Fire Tablet" does not want the West Valley shelter closed as Van Nuys is too far away, and said the shelters were paid for with tax dollars. Chris Rowe wanted to mention there are two important meetings coming up: a forum on Storm Water next Tuesday from 4 to 6 PM, and the State Heritage Commission will discuss traditional historic properties including the need to preserve sacred land at the SSFL. Cathy said the West Valley Animal Shelter needs to reopen and NCs can make statements to the Animal Services Commissioners. Bill Rose said West Valley Christian Church is doing services online. Joanne Yvanek-Garb is working as a census supervisor. Corrine Ho said Mayor Garcetti is making the rounds

of NC Alliances and will be at the next VANC meeting. Christina Walsh said Board members should not interrupt speakers during public comment.

Announcements:

President Dan Brin introduced WHNC's new Neighborhood Empowerment Advocate, Betty Wong Oyama, who has been with DONE 20 years. Ms. Wong Oyama said to contact her with any concerns. She also said suspension letters are being sent to NC members who are not in compliance by acknowledging the Code of Conduct. Funding training can be taken virtually. <u>Betty.Wong@LACITY.org</u>

Semee Park of DONE asked for videos of NC activity and the community. A videographer will put clips together for use in election outreach. On Aug. 31 at 7 PM, DONE will hold a working group to revamp the website. Chris Rowe asked if stakeholders can participate in training and Ms. Park stated training is open to the public.

Tessa Charnofsky from Supervisor Kuehl's office said there are resources other than unemployment insurance to help those in economic difficulty such as Cal Fresh.

Eric Moody from CD12 said the staff is busy working to help those in need. LADWP is working on a plan to lower bills when everyone is at home using more electricity and water. They are working on the palm trees Historic Cultural Monument. No final decision has been made regarding the West Valley Animal Shelter and meetings are being held to discuss its future. It is closed but will reopen, possibly with a non-profit partner.

Tara Vahdani from LAUSD said the district will hold a Community Town Hall of Schools at Taft High School in Woodland Hills.

Tanaz Golshan from the Mayor's Office spoke about new grant, not loan, programs to help small businesses. LADWP is enforcing electrical service disconnects for business not conforming to COVID restrictions regarding gatherings.

Board Vacancy:

President Dan Brin announced a vacancy on the WHNC Board of Directors. Board member Anthony Brosamle has resigned his seat. Char Rothstein will chair the Ad Hoc Vacancy Committee.

Committee Reports:

Streets and Transportation: Anthony Scearce said LADOT is not acknowledging traffic requests at this time.

Public Safety and Emergency Preparedness: Bob Brostoff said the August committee meeting is cancelled. **Animal Services Liaison:** It is kitten season. Consider an adoption.

Budget Advocates: Patricia Bates introduced herself as the new Budget Advocates representative for the WHNC. She is honored to serve, and her priority is equity as the San Fernando Valley gets the short end of the stick when it comes to funding.

Homelessness Liaison: Marie Javdani said eviction moratoriums are set to end Sept. 30. This is set for review once a month and is not a rent forgiveness program.

AD HOC POLICE REFORM

MOTION

The tragic murder of George Floyd in Minneapolis has sparked one of the largest and most profound movements for social justice our country has seen. Like many other cities across our nation, Los Angeles has seen large displays of protest and unity. Early on, there were some reports of opportunistic acts of violence, vandalism and looting, however, the majority of these protests have been peaceful, powerful and served to bring our City together.

Peaceful and first-amendment protected demonstrations are continuing in Los Angeles, part of a national call for justice. Further, while more instances of restraint and professionalism were displayed by the men and women of the Los Angeles Police Department (LAPD), there were a number of instances where excessive force appeared to be used against protesters.

Of particular interest is Saturday, May 30, 2020, though it is not the only example. What started out as a peaceful, multicultural and multigenerational family-oriented gathering at Pan Pacific Park turned into violence and chaos by day's end.

The San Fernando Valley has had a rich history as the pastoral and agricultural heart of Los Angeles. Although growth and urbanization has transformed the Valley into a melting pot of suburban Los Angeles, the trees that were planted by the early pioneers and ranchers remain to tell the story of the past.

The City of Los Angeles has taken significant steps to preserve this history, especially in Council District 12, as seen with the Historic Cultural Monument designation of the Lassen Street olive trees (HCM No.49) in Chatsworth and the "E.T." deodar trees (HCM No. 41) along White Oak Avenue in Granada Hills. These trees and others across the City of Los Angeles help define the character and culture of their neighborhoods.

This is especially the case in West Hills, where the palm trees that line March Avenue between Ingomar and Justice Streets are cherished for their beauty and historic significance. Leading up to the original entrance to Rancho Sombra del Roble, the rural retreat of Union Oil Company geologist William W. Orcutt that is currently known as Orcutt Ranch Horticulture Center, these trees also have appeared in numerous movies television shows, including the 1976 film *Bad News Bears*.

The West Hills Neighborhood Council therefore asks Councilmember John Lee to submit a motion for the City Council to initiate consideration of the palm trees on March Avenue between Ingomar and Justice Streets as a City Historic-Cultural Monument under the procedures of Section 22.171.10 of the Administrative Code, and instruct the Planning Department to prepare the Historic-Cultural Monument Application for review and consideration by the Cultural Heritage Commission.

MOTION

As a result of the economic tumult resulting from the COVID-19 pandemic, small businesses have taken a beating. As the contours emerge of what the next phases of public health orders will look, many small business owners are struggling to imagine how their enterprises will survive. One industry that will surely struggle with continued physical distancing rules is the restaurant industry — and the City needs to consider how it can help the industry alive, businesses thriving, and workers employed.

Most restaurants, even popular spots in the LA food scene, survive on thin margins. If restaurants reopen for dine-in service under distancing rules that shave their seating capacity dramatically, they will not likely survive. The impact to Los Angeles economy would be extreme. Prior to the current crisis, the restaurant industry had faster job growth than any other sector of the city's economy, employing more than 125,000 people and increasing 3.3% per year. Restaurant workers are among the most economically vulnerable in the city, with an average annual income of barely \$22,000. The collapse of the restaurant industry would be catastrophic for the city's economy and ruinous for its workers. These effects would be particularly acute in communities of color, where hourly wage jobs provide a lifeline for immigrant families and minority-owned restaurants provide an important pathway to the middle class.

While many restaurants have quickly adapted to takeout and delivery-only business models, returning to profitability and full employment will depend on restoring dine-in service. However, until there is a vaccine, physical distancing requirements are likely to require restaurants to cut indoor dining room capacity by 50% or more--far below what is required for profitability. There is an urgent need for innovative ways to expand dining capacity or neighborhoods will lose beloved local institutions and Los Angeles will lose one of its defining cultural assets. Temporarily allowing restaurants to use some available space in the public right of way is a relatively simple and cost-effective way of boosting their capacity and helping them survive.

As other sectors of the economy continue to telecommute, lower traffic volumes are likely to persist even as the economy starts to recover. Furthermore, with lower occupancy, restaurants will need less parking for customers. The City should create opportunities to repurpose underutilized street space and parking lots to support the economic survival and recovery of the restaurant industry. Expanding outdoor dining will help restaurants return to profitability, restore staffing levels and incomes for workers, and provide customers with a healthier and safer dining environment consistent with public health guidelines.

The City's existing sidewalk dining program offers one model for allowing restaurant expansion into the public right-of-way, but few sidewalks are wide enough to meet requirements and restaurants report that the permitting process is cumbersome and expensive. Other programs, such as LADOT's People Street, convert underutilized roadways into parklets and pedestrian plazas, but don't currently allow for table service. A new program is needed that combines the best attributes of these existing programs, but is also flexible and affordable for struggling restaurants with limited funds and unique space constraints. The City should act urgently to adapt these programs to meet the current needs of the restaurant industry and ensure that they are available in time for the resumption of dine-in service.

I THEREFORE MOVE that the City Council direct the Department of Transportation (LADOT) and Bureau of Engineering (BOE) to report back with a streamlined and affordable program for permitting restaurants to provide dine-in service within the public right-of-way that can be launched as soon as allowed by public health rules.

I FURTHER MOVE that the City Council direct the Department of City Planning to report back with recommended actions to temporarily suspend parking requirements and other applicable codes to allow for the conversion of private parking lots to dining space at existing restaurants.

One of the principal mandates of the West Hills Neighborhood Council (WHNC) is to promote the wellbeing and safety of the community's stakeholders.

Ever since Valley Circle Boulevard opened up to connect the 101 Freeway and Chatsworth, residents along this stretch of road have endured loud and life-threatening exhibitions of speed almost on a nightly basis.

The problem also extends to Roscoe Boulevard, Vanowen Street and other east-west streets that intersect with Valley Circle, leading to many accidents and deaths over the years.

Stakeholders also have reported to the WHNC's Streets & Transportation Committee that drivers are altering the exhaust systems on their cars, trucks and motorcycles, intentionally generating sounds similar to explosions and gunfire. This has caused residents to be startled awake in the middle of the night and causing many to make 911 calls to the police.

The reckless driving, speeding and noise can be mitigated with increased patrolling and ticketing by law enforcement during the day and especially at night.

Therefore, the West Hills Neighborhood Council implores police and public officials to immediately address these pressing issues by stepping up traffic and vehicle code enforcement along Valley Circle Boulevard and adjoining streets. Failure to act now would put the safety and wellbeing of our stakeholders at unnecessary risk.

We also support efforts by other Neighborhood Councils to address these problems on a citywide basis.
