Chair Comments: Dan Brin announced the passing of WHNC Board member Ron Sobel and LAPD Senior Lead Officer Sean Brown. A moment of silence was observed.

Induction of Board Member Marie Javdani: Ms. Javdani recited the Neighborhood Council Oath. Mr. Brin officially seated Ms. Javdani on the Board of directors of the West Hills Neighborhood Council.

Mr. Brin announced the WHNC has a vacancy. The application period will be open for 30 days and the Board will select a new member in January 2021.

The minutes from the October 2020 meeting were approved as amended.

Treasurer's Report:

20-0104 - Discussion and possible action regarding approval of the WHNC's September 2020 Monthly Expenditure Report (MER). Treasurer Carolyn Greenwood said the only expenses were regular monthly expenditures.

Mr. Brin said he and Sandi Bell presented a Certificate of Appreciation to the CEO of West Hills Hospital.

Controller's Report: Controller Saif Mogri reported the October spending. There were four invoices for the Halloween event for the award items and printing. Amazon double-invoiced an item but then removed the extra charge. Mr. Mogri added a column for invoice numbers to the report. He plans to add an additional column for the date the invoice is paid by the city.

Budget Report: Alec Uzemeck said there is currently an error of \$10.00 in the budget report, which he will correct.

Public Comment: None

Announcements:

Eric Moody, District Director, CD12 – The council district office is organizing community cleanups. Additional CARES Act funds are now available to aid restaurants in implementing al fresco dining. He thanked WHNC for participating in the recent Conversations with Councils. Councilmember Lee is pressing to reopen the West Valley Animal Shelter by the end of the year. CD12 continues to deliver senior meals on Thursdays.

Betty Wong-Oyama, Neighborhood Empowerment Advocate - To meet the Planning 101 training requirement, DONE is asking for Board action to ratify members of the NC's planning committee. The results should be submitted on the DONE template. There will be Zoom training in November and December with dates to be announced. A City Clerk Event Approval Request Form is not required for virtual events that do not include spending NC funds.

Upcoming training: Funding – Tuesday, Nov. 10, 2-4 p.m.; Tuesday, Nov. 24, no time stated. Social Media – Thursday, Nov. 12, 2-3:30 p.m.; Thursday, Nov. 19, no time stated.

Ms. Wong-Oyama announced she will retire in early 2021. Dan Brin and many members said they will be sorry to see her leave but wish her all the best.

Becca Brukman, representing Jesse Gabriel, California Assembly District 45 – The Assembly member will host a drive-through-open-house event on Thursday, Dec. 10, at the West Valley Food pantry. She will send details.

Tessa Charnoffsky, representing Supervisor Kuehl, District 3 – There were no major incidents at voting centers in the district. There will be a Parent Town Hall on Nov. 9 at 6:00 p.m.

Tara Vahdani, representing Scott Schmerelson, LAUSD District 3 – Justice Street Elementary is having a Turkey Trot all November; entry fee is \$25 and includes a T-shirt. Hamlin Charter Academy is holding a virtual Interactive Baking Experience on Nov. 13 at 1:30 p.m. LAUSD Virtual Town Halls will continue this month with a focus on hybrid learning and returning to school. The next Coffee with the Superintendent takes place on Dec. 1, 9-11 p.m.; people who do not have schoolchildren are welcome to ask questions. Grab-and-Go food centers are still operating.

Streets and Transportation – Committee Chair Anthony Scearce said 19 trees were planted at Lazy J Ranch Park. He also said the utility box artwork project is fully approved and painting should begin next week.

Zoning and Planning: Committee Co-Chair Charlene Rothstein announced the meeting will move from the regular meeting day to Monday, Nov. 23. Normal schedule resumes in December.

Old Business:

20-0096 – CIS for CF-20-1267 (vehicle noise) and letter to CD 12 and city representatives regarding excessive vehicle exhaust noise and speeding/reckless driving exhibitions of speed: Dan Brin read the proposed letter. Myrl Schreibman said he does not feel the letter relates to the motion. After a discussion on the proper focus and scope of the letter, Anthony Scearce and Dan Brin agreed to restructure the letter.

Amendment to have the letter restructured to lead with modified exhaust and continue with speeding. Yes - 20, No - 0, Abstain - 0, Abstain - 1, Ineligible - 0, Recused - 0

The amendment carries.

New Business:

20-0105 - Vacant seat on the West Hills Neighborhood Council Board vacated by Bobbi Trantafello: Ad Hoc Vacancy Committee Co-chairs Charlene Rothstein and Steve Randall described the vacancy process and praised all candidates. Secretary Brad Vanderhoof explained that per the WHNC Bylaws a vacancy must be filled by a majority vote (more than 50% of votes cast) and a plurality (highest number of votes) is not sufficient. Mr. Randall said if a majority is not reached there would be a runoff. This seat has a term with 2½ years remaining.

The candidates are Bethany Jones, Brian Begun, Esperana Butler, Ymileth Jimenez-Garcia, Daniel Oszreicher, Cara MacIntosh. Each candidate spoke for two minutes. Ms. Jimenez-Garcia withdrew, citing the storm crisis in Central America. Mr. Randall said the committee recommended Bethany Jones for this seat.

In June, 2020, Louis DeJoy, a person with no prior USPS experience but with alleged financial interests in competing private shipping firms, was appointed Postmaster by President Donald Trump. DeJoy immediately made obstructive changes to the Post Office, including firing most senior staff, removing post office drop boxes and mail sorting machines, eliminating overtime and other measures designed solely to prevent on-time mail service. In early August, 2020, the Post Office gave notice to 46 states that it could NOT ENSURE that all ballots cast in November election would be delivered on time to be counted. President Trump announced on August 13, 2020, that he would veto any funding effort aimed at ensuring timely and uninterrupted delivery of mail, citing the presidential election. The Chair of the House Oversight and Reform Committee introduced HR 8015, "Delivering for America" Act, which declared that there will be no changes to the operation, functions, postal standards, and purpose of the USPS that could delay mail or allow non-delivery of mail while under COVID-19 pandemic declaration. Congress must act to ensure the success of the USPS in its mission to provide mail and delivery services throughout the US as

mandated in the Constitution.

Since 1775, USPS has provided and continues to provide crucial delivery service for all kinds of mailings and parcels, as well as providing a lifeline to rural area residents who are out of reach of commercial parcel services and accessible internet connectivity. USPS continues to enjoy support from 90-plus percent of Americans. For the last several decades, special interests and conservative policymakers have promoted privatizing USPS based on USPS's very affordable service conducted at a budgetary loss in order to generate a more commercial, for-profit business. USPS was created precisely to be an absolutely necessary service but unprofitable, which service would be severely disrupted by privatization. President Trump has taken steps to "reform" USPS, but those steps are really steps to slow down nationwide postal deliveries, inconvenience millions of citizens, disrupt

businesses and threaten the vote-by-mail operations during a pandemic and an important national election. HR7015 will properly fund USPS, halt and/or reverse all detrimental operational and

This Resolution seeks to establish LA City's position regarding the City's 2019-2020 Federal Summary: Legislative Programs to support any administrative or legislative action to prohibit forced hysterectomies at ICE detention facilities. The US Immigration and Customs Enforcement (ICE) is infamous for its actions to repeatedly target communities of people of color with immoral tactics, including physical and psychological trauma caused as a result of deplorable conditions at its detention facilities, including but not limited to inadequate response to the COVID-19 pandemic. A whistleblower complaint about Georgia's Irwin ICE Detention Center fully sets forth mistreatment, poor conditions, and a large number of female detainees forced to undergo unnecessary hysterectomies without their knowledge or consent. These women detailed excruciating pain after being robbed of their reproductive rights without medical basis or justification. Such an inexcusable ordeal is a violation of human rights, for which all participating parties should be immediately identified and held accountable. A 2017 report from the same Irwin ICE facility exposed unsanitary conditions, inedible food and insufficient medical care. These reports delineate and demonstrate these conditions are neither new nor isolated. Rather they are symptomatic of a larger system which denies basic human rights to individuals based on their immigration status. These violations are further compounded by the women's difficulty in assessing or complete lack of access to adequate feminine hygiene products or contraceptive services. Any and all such forced and unnecessary hysterectomies should be prohibited at all ICE detention facilities.

WHEREAS, any official position of the City of Los Angeles with respect to legislation rules, regulations, or policies proposed to or pending before a local, state, or federal governmental body or agency must have first been adopted in the form of a Resolution by the City Council with the concurrence of the Mayor, and

WHEREAS, on October 20, 2020, a Joint Status Report filed with the United States District Court of the Southern District of California, revealed that 545 children who were separated from their families under the Trump Administration "Zero Tolerance Policy," have not been reunited with their families; and

WHEREAS, according to the American Civil Liberties Union (ACLU), over 5,400 children, including those under five, toddlers, and babies, were separated from their parents pursuant to the Zero Tolerance Policy; and

WHEREAS, the decision to separate children from their families is cruel, traumatic, inhumane and disgraceful but consistent with the actions of the Trump Administration, which seem fixated on maximizing harm to immigrants in any way possible; and

WHEREAS, the ACLU reports that the sole purpose of the child separation policy was to discourage immigration to the U.S. and no tracking or monitoring mechanisms were established for the eventual reunification of these children with their families; and

WHEREAS, in 2019, the Trump Administration went to court to argue that migrant children detained at the U.S.-Mexico border do not require basic hygiene products like soap and toothbrushes in order to be held in "safe and sanitary" conditions, and that requiring minors to sleep on cold concrete floors in crowded cells with low temperatures was also considered "safe and sanitary," and

WHEREAS, the Trump Administration's action are in direct violation of the Flores Agreement and other federal immigration laws that specifically provide guidelines with respect to the arrest, detention, treatment, and transfer of children detained by federal immigration authorities; and

WHEREAS, most separated children did not receive due process and, many as young as three years old, were ordered into court for their own deportation proceedings without counsel; and

WHEREAS, the City of Los Angeles strongly denounces the actions by the Trump Administration, including the child separation practice, the Zero Tolerance Policy, and other actions that have inhumanely targeted undocumented immigrants; and

WHEREAS, the City calls upon every member of the U.S. Senate, House of Representatives, and the Office of the President to enact legislation to ensure that under no circumstances, aside from any threat of abuse or neglect, should children ever be separated from their parents as they seek to the enter the U.S. through asylum or any other means;

NOW, THEREFORE, BE IT RESOLVED, with the concurrence of the Mayor, that by adoption of this Resolution, the City of Los Angeles hereby includes in the 2019-2020 Federal Legislative Program SPONSORSHIP and/or SUPPORT of legislation to ensure that under no circumstances, aside from any threat of abuse or neglect, should children ever be separated from their parents as they seek to the enter the U.S. through asylum or any other means, including legislation that strengthens and guarantees the right to family integrity and procedural due process laws, U.S. asylum statutes which guarantee the right to apply for asylum, the Administration Procedures Act (APA) which prohibits arbitrary government action, and the Flores Agreement which prescribes national standards for the housing, detention, and release of children detained by federal immigration authorities.
