Committee members in attendance: Steve Randall, Alec Uzemeck, Brad Vanderhoof and Saif Mogri

Attendees: Chris Rowe, and Bonnie Klea.

At 7:08 Co Chair Steve Randall opened the meeting and established a quorum.

The minutes from the Novembe 14, 2020 meeting were approved.

Comments from the Chairs: Steve and Alec did not have any comments.

Sasha Watts, representing the Climate Reality organization which was established by Al Gore, spoke about climate warming caused by gases from auto emissions, power generating plants and industrial processes, and how that warming was causing melting of polar ice, warming and acidification of the oceans, increased storms and negative effects on human health. In the future we should increase the uses of efficient machines and renewable energy sources and she asked for support of the Climate Reality group with volunteer work, lobbying and contributions.

Christina Vega spoke as the outreach person representing the Aliso Canyon Disaster investigation team. She described the team's organization and goals for the investigation, and she committed to provide monthly activity reports to our committee as the team starts gathering and analyzing data.

There were several questions to the speakers on the technical aspects of their presentations.

Steve adjourned the meeting at 8:16 PM.
