Those in attendance were: Tony Brosamle, Brad Vanderhoof, Aida Abkarians, Faye Barta, Ivan Blume, Dan Brin, Matthew Davine, Heidi Manning, Steve Randall, Myrl Schreibman, Barry Seybert, Ron Sobel, and Joan Trent.

Committee Co-Chair Brad Vanderhoof called the meeting to order at 6:35 PM. A quorum was established.

The September 2017 Joint Beautification Committee/Board Meeting Minutes were approved as amended.

Numbers refer to agenda items:

3. Chair Comment: None4. Public Comment: None

- 5. Review of October 14th Cleanup Project: Myrl emphasized the point that the effort ended at Pomelo and did not complete work to Cohasset as advertised in the flyer. Dan mentioned he spoke to a property owner about their responsibility to maintain the adjacent right of way. Tony informed the group that the department of Sanitation has complained to CD12 about the way bags are left after WHNC Cleanup events. Sanitation would prefer one pickup location. Tony stated the Committee will have direct communication with the Department.
- 6. The Church at Rocky Peak All Serve Event: Brad provided an update on status of all projects. The Cleanup location was formally moved to Roscoe near Orcutt Ranch. Meeting location for all projects is the parking lot at Orcutt Ranch.
- 7. December Cleanup Event: Suggestions; Myrl Platt from Pomelo to Cohasset, Dan Woodlake from Saticoy to Cohasset, Matthew Fallbrook from Saticoy to Ingomar. The group decided on December 9th, Fallbrook, and the Little Caesar's parking lot as the date, location, and meeting place for the December Cleanup event.
- 8. Free-Tree-Give-Away: no update
- 9. R.O.W. Letters: Tony reported Tom Booth's nomination of 23612 Lauren a massive bougainvillea blocks the sidewalk along Saticoy. This property has received both the brochure and initial letter. All the other property owners on that block have taken responsibility after receiving the brochure.
 - Steve moved to issue a follow-up letter. Barry seconded. The motion passed with no opposition and one abstention. The letter will be placed on the door of the home. Tony and Brad have responsibility.
- 10. Strike Teams and MyLA311 Walks: Heidi, Dan, and Brad cleaned illegally dumped debris from a section of Woolsey Canyon. Aida reported graffiti at Four Oaks Park. Steve trimmed some trees obscuring stop signs. Ivan mentioned Keller Williams is looking to get involved in community engagement projects.
- 11. Parkway Maintenance Brochures: Brad reminded the group to provide addresses if brochures are distributed. In response to a question, Brad and Tony stated that all committee members are empowered to decide where brochures are needed and to distribute them.
- 12. Murals in West Hills: Brad informed the group the approval process is lengthy and difficult, and the co-chairs are investigating. Myrl asked for a copy of the information.
- 13. Newsletter Icon: tabled to December, committee members invited to submit suggestions

Committee Co-Chair Brad Vanderhoof adjourned the meeting at 7:46 PM.

Committee Co-Chair Anthony Brosamle called the meeting to order at 6:32 PM. A quorum was established.

The October minutes were not available for approval.

Numbers refer to agenda items:

3. Chair Comment: None4. Public Comment: None

- 5. November Cleanup Event and All Serve Day Projects: Anthony praised participants for doing a fantastic job. Several committee members expressed disappointment at the low turnout. Heidi commented she especially likes the results from the free-the-trees project and would like to see that effort expanded. Dan verified acetone was used as a solvent for the hydrant painting project.
- 6. 2018 Service Project Planning: Many ideas were introduced in a round table discussion; Steve dog park at Highlander, Joan Rocky Peak accepts projects and recruits all year, Brad Pastor Morehead commented the house referred by WHNC was an excellent project, Faye increase turnout by signing up youth groups to commit to a specific event, Tom Welcome sign on Valley Circle median, Myrl spring planting, Dan remove asphalt in medians and replace with landscaping, Ron address Dept. of Rec. and Parks maintenance shortcomings, Heidi remove dead parkway trees and replant, Olivia dog waste stations at existing parks, uniform landscaping on major street medians to give a consistent look and feel to West Hills.
- 7. Budget: The co-chairs explained most of the committee's budget is unspent and we need to start planning. Tom suggested maybe a contractor could be hired to remove tree surrounds. He will think about developing a proposal. Dan suggested litter grabbers. Brad stated the committee needs replacement work gloves, dust masks, and string trimmer consumables.

 Anthony moved to authorize an expenditure not to exceed \$350 for personal protection supplies (gloves and masks), string trimmer spools and parts, and grabbers. Steve seconded. The motion passed unanimously. The co-chairs will prepare and submit a funding request.
- 8. December Community Cleanup Event: Anthony reiterated the details of the December event.
- 9. Platt and Highlander, Stakeholder Complaint: Brad explained the committee received a complaint via Facebook concerning the hillside maintenance on the north-west corner of the intersection. A ROW letter will be considered at the December meeting.
- 10. R.O.W. Letters: Anthony and Brad will follow up to make sure the previously approved letter is delivered.
- 11. Strike Teams and MyLA311 Walks: Steve stated he thinks there should be an emphasis on trimming trees and shrubbery that block traffic signs. Heidi and Brad filled 13 bags with debris along Valley Circle immediately following the All Serve Day. Dan and Ron have continued to remove illegally posted signs.
- 12. Parkway Maintenance Brochures: no updates, Tom has updated the spreadsheet.
- 13. Murals in West Hills: Item tabled to December.
- 14. Newsletter Icon: Item tabled.

Committee Co-Chair Anthony Brosamle adjourned the meeting at 7:40 PM.
