# JOINT BEAUTIFICATION COMMITTEE/BOARD ONLINE AND TELEPHONIC MEETING MINUTES

Tuesday, August 25, 2020 @ 6:00 PM Revised August 26, 2020

Committee Co-Chair Faye Barta called the meeting to order at 6:13 PM.

Those in attendance: Faye Barta, Brad Vanderhoof, Tom Booth, Dan Brin, Kian Gholibeik, Heidi Manning, Olivia Naturman, Steve Randall, Anthony Scearce, Myrl Schreibman (arrive 6:35 PM), and Joan Trent

A quorum was established.

The July 2020 minutes were approved as amended.

### Numbers refer to agenda items:

- 3. Comments and Announcements from the Chairs: Faye thinks these meetings are good news in trying times and provide some interaction with the stay at home order. Faye also said she has heard reports of dead crows that may be due to West Nile virus. LA County will be spraying in West Hills to control mosquitoes.
- 4. Public Comment: None
- 5. Shomrei Torah's request for Beautification Committee Input and Advice on Establishing a Community Garden or other Improvement on the Vacant Triangle Lot on Valley Circle South of the Synagogue: Gil Solomon spoke desire for a garden. Judy's iPad has approached Shomrei Torah and they would like something other than a vacant lot. She has tried and made no progress getting LADWP to say what it would take to get water to the property. She said they own the lot. Reeyan Raynes said the issue came up many years ago when he was co-chair of this committee and he remembers the parcel is owned by a utility company. Gil said the part of the parcel is right of way for Valley Circle. The right of way is extremely wide and crosses the sidewalk. Shomrei Torah does own the rest and it used to be contiguous with their main property. This was before the Castle Peak Estates and Indian Hills Lane construction. There is a utility right of way through the center of the property giving them right of usage but not ownership. Dan suggested using a hose to water. Heidi suggested rainwater capture and asked if the project could incorporate a mural. Faye suggested an overflow parking lot instead of a garden. Faye also said the garden may be restricted to non-edible plants due to possible contamination from the SSFL cleanup. Judy said Shomrei Torah's goal is to grow produce for local food banks. Reeyan said the City's Office of Community Beautification has a program called Urban Agriculture Incentive Zone (UAIZ) to promote food production on underutilized parcels. Gil will investigate the program. Dan said the SSFL cleanup truck route has not yet been determined. Reeyan said the parcel does qualify for UAIZ.

- 6. Future of Community Cleanups (update) and LA City Park Maintenance (update and subcommittee/assignments): Dan said he spoke with Mike Castro, Department of Recreation and Parks, who is overwhelmed with only 20 staff members to do the work of 200. Myrl asked if we could help on a limited basis. Brad answered yes but we cannot advertise as the WHNC or invite a large group, as that would require an event permit and violate the stay at home order. Joan said a while ago she and Thomas went to a house on Capistrano and left our brochure and her phone number. The homeowner called her and has now done the needed maintenance on the property. Everyone thanked Joan and Thomas for there extra effort to reach out to a stakeholder. Faye will contact Mike Castro about the possibility of volunteering at parks. Reeyan said Scott Harmon is a good contact for problems with parkway trees. Gil said he reported a dead tree and it took 9-12 months before the City removed it. Anthony said Taxco Trails Park looks pretty good, but Lazy J Park is in terrible shape with parched grass and numerous gopher holes. Normally the sprinklers come on Saturday morning at Taxco Trails but this last Saturday they did not and it is beginning o dry out. Heidi said John, who attended the July Beautification Committee meeting, is still writing to CD12 to get water restored to Lazy J and street medians.
- 7. Other Beautification Projects: Heidi explained the information she has learned about the Adopt a Median program. Steve said we need to focus on stakeholder participation. Brad, Reeyan, and Olivia all discussed the contract in perpetuity clause in many of these city programs and the incredible difficulty it poses for NCs to participate.
- 8. R.O.W. Letters: Dan said there is still no activity along Fallbrook at the houses on Maynard (7619, 7625).

Brad moved to send R.O.W. letters. Dan seconded.

Yes -8, No -2, Abstain -0, Absent -2The motion passes. R.O.W. letters will be sent.

9. Strike Team Reports: None. Brad commented lately it has been awfully hot for most activities.

Committee Co-chair Faye Barta adjourned the meeting at 7:16 PM.
