Committee Co-chair Anthony Scearce called the meeting to order at 6:30 PM. A quorum was established. Comments from the Co-Chair(s): None Announcements: None Public Comment: None

Numbers refer to agenda items.

1. Approval of Minutes: from September 20th, 2022. The minutes were approved as amended.

2. Solutions for speeding on Platt between Ingomar and Sherman Way: Myrl said Platt is being used as a raceway since the repaying. Heidi suggested a camera to provide information to the LAPD. Steve suggested speed tables. Caller 229 spoke about drag racing along Roscoe between Valley Circle and Fallbrook. After a lengthy discussion this item was tabled to December.

3. Partially blind intersection at Valley Circle Blvd. and Strathern St.: No stakeholder was present to speak so the item was tabled to December.

4. Traffic Control Cabinet on Jason and Roscoe with safety message facing Roscoe and "West Hills Neighborhood Council" facing Jason: Anthony said the box was struck by a car and destroyed. The replacement box is blank and the artwork needs to be redone. Christina Walsh (artist on the box that is now gone) spoke on her discussions with DOT, and gave ideas on replacement artwork. Christina left the meeting. Anthony said other artists will be offered the opportunity to submit proposals. Item tabled to December.

5. Funding request for \$300.00 for painting Traffic Control Cabinet on Jason and Roscoe: Item tabled to December.
