OPENING BUSINESS

President and Co-Chair Dan Brin called the meeting to order at 7:00 p.m. Secretary Nicole Flessati called roll and announced an initial attendance of 24 board members, establishing a quorum. Vice President and Co-Chair Charlene Rothstein led the Pledge of Allegiance. September 2015 meeting minutes were approved.

COMMENTS FROM THE CHAIR

President Dan Brin announced the upcoming Neighborhood Council Elections. Ed Young was injured but is expected to make a full recovery but is not in attendance due to the injury. Note the passing of two members of our community that passed away in a fire the day before the meeting.

ANNOUNCEMENTS

Dusty Russell - Announced a bill calling for a moratorium of injections into the well, the legislation is in the State Assemby. The senator is working on developing priority for the year, to focus on teacher shortage here in los angeles. In addition to all that, he is here to recognize the work of the neighborhood council and one member in particular, Reeyan Raynes. She wants to recognize a volunteer of the month award to honor his work.

CD 12 – Ron Rubine, Field Deputy mentioned that the no parking signs will be going up. Councilman is working with authorities to help the displaced families of the Aliso Gas leak move West Hills Neighborhood Council

back into their homes in a realistic timeframe. There will be a closed hearing on the Haynes Street Bridge on February 19.

Assembly member Debabneh was in attendance. His office is working with the Gas company and has asked for regulations from them to ensure that a leak doesn't happen again. Another good year for the state budget a \$170 million dollar budget. That means more money for in-state schools to allow for more acceptance to avoid losing promising students to other states - this includes Community College, Cal State, and UC's. They are reinvesting in social security. environmental protections are in place, like the Chatsworth pond situation where state money doesn't make its way to the local areas, including to the local schools. One of his office is frugal and is insisting on a rainy day fund. Gov. Brown took a \$60 billion deficit and in 3 years made it flat, there is now a rainy day fund to allow for market dips in a bullish economy. Working hard on affordable housing. We need to update our roads. He's the chair of the banking finance committee, worked on regulating virtual currency and looking at ways to implement card chip technology - which is safer and has increased fraud protection. Payday lending is another issue in California, they are trying to prevent the debt trap caused by abusing these funding options. His office is trying to work on alternatives for those community members that do not have access to regular loans or family like from Credit Unions and other community based options. He's also working on fraud calls like the IRS scam as well as other email scams. He says the Government would never ask for your personal information via telephone calls or emails. Call his office if you have any concerns about the aforementioned topics.

Howard Ketchum our independent election coordinator spoke to the board about the upcoming election.

Everet Kang, Vice President of Architecture and Planning of D.R. Horton spoke to the board about the development at 8500 Fallbrook Ave that they purchased from California Home Building. His goal is to build the best product and increase property values for all neighbors. Lori Yalem spoke to the board about her concern regarding the Small Lot Sub Divisions being approved for development in West Hills and asked that the council support the desires of the neighbors and stakeholders in regards to the development size. She is urging the council to develop more parks and to keep track of the quimby funds from these ongoing developments. She also recognized that the community needs a dog park.

Aisso Fernandez and Lili Lozano from the West Valley Boys and Girls Club College Bound program spoke to the board about the program.

RESOLUTION

WHEREAS, any official position of the City of Los Angeles with respect to legislation, rules, regulations or policies proposed to or pending before a local, state or federal governmental body or agency must have first been adopted in the form of a Resolution by the City Council with the concurrence of the Mayor; and

WHEREAS, more than 100,000 American veterans who served in the military during World War II, Korea, Vietnam, the Gulf War, Iraq, and Afghanistan received less than honorable discharge from the military because of their sexual orientation, often resulting in a loss of benefits to which they should have been entitled, such as veterans' health care and GI bill tuition assistance; and

WHEREAS, in 2011, Congress and the President repealed the "Don't Ask, Don't Tell" policy to eliminate this institutionalized discrimination and allow all members of the military to serve their country freely and openly, regardless of their sexual orientation; and

WHEREAS, despite the change in policy, estimates are that nearly 114,000 LGBT service members who were discharged over the years under prior policies continue to suffer from tarnished military records, often preventing them from receiving the veterans' benefits they rightfully earned; and

WHEREAS, on July 15, 2015, Senator Brian Schatz and Congressman Mark Pocan introduced companion measures S1766 and HR3068, respectively, proposing the enactment of the "Restore Honor to Service Members Act"; and

WHEREAS, if enacted, the Restore Honor to Service Members Act would streamline the process through which veterans who were unduly discharged solely because of their sexual orientation can have their military record corrected to reflect an honorable discharge, thereby becoming eligible for any veterans' benefits they are due; and

WHEREAS, on numerous occasions, the City of Los Angeles has gone on record in strong support of the legislation and policies that uphold the rights of all individuals and eliminate all forms of discrimination, including sexual orientation, and these two federal measures are consistent with Council Policy.

NOW, THEREFORE, BE IT RESOLVED, with the concurrence of the Mayor, that by the adoption of this Resolution, the City of Los Angeles hereby includes in its 2015-16 Federal Legislative Program SUPPORT for the "Restore Honor to Service Members Act," HR 3068 (Pocan) and S1766 (Schatz), which would simplify and streamline the administrative process to allow veterans who received less-than-honorable discharges solely because of their sexual orientation to clear their military record and become eligible for all benefits and veterans' services to which they should be entitled.

Proposed WHNC Bylaws amendments

Section 6: Vacancies on the Board

Vacancies on the Board shall be filled using the following procedure:

- A. When a *seat becomes vacant* vacancy is created on the Board, a notice shall be posted immediately wihin 72 hours on the WHNC website, and by posting a notice in a public place, by sending an email via the WHNC email list, and by announcing it at the next *regular* board meeting.
- B. Timelines and details for the process shall be detailed in the WHNC Standing Rules.
- B. Any qualified Stakeholder interested in filling a vacant seat on the Board shall submit an application to the Secretary within 30 days after posting of the vacancy. Such application forms may be available on the WHNC website or may be obtained by written request to the secretary of the WHNC.
- C. The Secretary shall immediately transmit the application to the Chair of a designated committee for review and action.
- D. The designated committee shall meet within 15 days of the filing deadline. The committee shall review the applications to ensure that the applicants are eligible to hold the office and are otherwise qualified to undertake the level of participation expected of Directors of the Board of the WHNC.
- E. The committee shall submit all applications and shall make a recommendation of a qualified candidate to the President within ten (10) business days of its decision. The President shall have the filling of the vacancy placed on the agenda for a vote at the next Board meeting.

Aliso Canyon Gas Leak

Dear Councilman Englander:

The methane gas leak in Aliso Canyon near Porter Ranch is an environmental disaster that has created hazards to human health and long-term impacts on the Earth's atmosphere. At its meeting on February 4, 2016, the board of the West Hills Neighborhood Council approved the following resolution.

"The residents of West Hills are strongly concerned that the methane passing over the San Fernando Valley presents an immediate threat to human health and it contains carcinogenic components that may create long-term illnesses.

"Be it resolved that the West Hills community requires information about the consequences of the gas leak and what actions should be taken to mitigate harmful effects. We request that air sampling and testing be done in West Hills and adjacent communities. Further, the results should be made public and recommendations made so that families may take appropriate steps.

"In the past, during periods of heavy smog, people were told by the AQMD about climate conditions and level of exposure. On bad days, children were kept inside of schools without outside activity and other limitations were placed on the public to minimize harm. We recommend that a similar warning system be set up for residents so they are made aware of hazards and can act accordingly. The use of social media and traditional means could be effective for these purposes.





"It is clear that the leak must be corrected immediately, but this accident is a wakeup call for local politicians, legislators and regulators. The present infrastructure must be examined, repaired or replaced, have safety devices installed and have regular state inspections. These recommendations should be made into laws with severe consequences enough to avoid the harm that could be repeated in the future.

"We are told the Gas Company did not break any laws or regulations in operating its plant and that the developers' plans were approved without consideration that new homes would be built next to an industrial site, but this disastrous accident did occur.

"All parties, developers and zoning commissions, should completely evaluate the interface of major industrial operations and housing developments, because these types of operations and developments are present in West Hills and other parts of the San Fernando Valley."

CF-15-1138-S1, LA Homeless/New Account*

From the Ad hoc Committee on Homelessness with a recommendation to support.

In the past, the City and County of Los Angeles focused independently on solutions to homelessness. Now, for the first time, they are implementing a collaborative plan.

The long-term strategy to combat homelessness begins with the Comprehensive Homelessness Strategy**. It is the collaborative efforts of the City, County and nonprofits to end homelessness in L.A. City and County over the next 10 years.

It uses best practices from all around the country and of course our own proven best practices. Focus will be on immediate housing and <u>more</u> immediate housing, addiction services, medical and mental health care, training, hiring, and the City's interaction with homeless people.

The Ad hoc Committee on Homelessness is following the implementation of the Strategy as its components (motions) make their way through the City's Homelessness and Poverty Committee to the Mayors desk. We are also watching the Board of Supervisors move actions forward. We will report to you from time to time on the implementation process and will come back to you with additional CIS requests.

CF-15-1138-S1** is a 4 part motion

The first action is to open a new bank account specifically for the deposit of funds to combat homelessness. If you reference the Comprehensive Homeless Strategy, page 199 "Budget", you can read all about funds and funding, public and private grants and the like.

Second action, have the CAO and CLA report on a multi-year spending plan prioritizing permanent supportive housing, shelter and services for homeless folks.

3rd action, find any un-budgeted and un-allocated revenues that can be deposited on a one time basis into the account and report back as soon as possible, but no later than mid-year.

4th action, report back on existing appropriations as soon as possible, but no later than mid-year.

Motion: The Ad hoc Committee recommends a yes vote on CF15-1138-S1, and that this decision be added to the Council File as a Community Impact Statement.

MOTION HOMELESSNESS AND POVERTY

The homelessness crisis is a moral, humanitarian and public health crisis that affects every resident of the City of Los Angeles. Suitable and permanent shelter is a basic need, and the lack thereof can have a damaging effect upon physical and mental health. Groups who have historically been discriminated against, such as ethnic minorities, disabled persons, persons with mental Illness, women, children and youth, have been disproportionately affected by the city's lack of affordable and suitable housing.

On July 2nd, 2015 the Homelessness and Poverty Committee was created to act immediately and boldly in addressing homelessness. The Homelessness and Poverty Committee has directed City staff to develop a strategic plan for homelessness, which it expects to hear this December. Among the issues being heard in Committee and expected to be incorporated into the plan are cost-effective housing strategies and the gap between supply and demand for housing for the homeless; expanded outreach and services; strategies to improve City interactions with individuals experiencing homelessness; programs to divert people from homelessness at the time they are in the care of emergency responders and health care providers; and opportunities to better coordinate with County and other partners.

In responding to the challenges of homelessness, it is of critical importance that the City maintain and improve upon its collaboration with the County of Los Angeles, which is generally responsible for social services. A stronger collaboration with the County of Los Angeles would make it possible for people to receive regular medical and mental health care, as well as provide assistance for substance abuse and addiction among other much-needed services that would address the root causes of homelessness.

The City of Los Angeles has weathered the national recession and today stands on significantly improved financial footing. It can now claim the highest budget reserves in the city's history. In order to ensure that the Homelessness and Poverty committee is able to put forth an effective strategy for providing housing options for those living on our streets, the City of Los Angeles should capitalize on the fiscally responsible actions taken in recent years and work toward providing additional resources to be used to take people off the streets and into homes.

These additional resources could be used to fund a number of successful models to move people from the streets and into housing or permanent shelter. A universe of potential options could include: construction of permanent supportive housing; creation of a city program to provide vouchers for rapid rehousing or interim housing; improvements to existing programs that could expedite the process of moving people into housing; financing of an expanded system of emergency or specialized shelters and safe parking; and the provision of storage facilities and restrooms for people without shelter. This one-time investment can also leverage other government or philanthropic funding.

I THEREFORE MOVE that the Controller be authorized and instructed to create a new account in the Unappropriated Balance (UB) entitled Serving and Housing LA's Homeless;

I FURTHER MOVE that the City Administrative Officer (CAO) and the Chief Legislative Analyst (CLA) be instructed to develop and report to the Council a multi-year spending plan to reduce homelessness in the City of Los Angeles by using a number of funding sources with the goal of committing up to, but not limited to, \$100 Million of city-accessible funds. The plan should be developed under the direction of the Homelessness and Poverty Committee, in consultation with the Mayor's Office, County of Los Angeles, Los Angeles Homeless Authority and appropriate City Departments by January 1, 2016. The Plan should prioritize providing permanent supportive housing, shelter and services to persons experiencing homelessness, including homeless persons with disabilities, and should identify ways to leverage this investment to ensure an on-going revenue stream to support the program.

I FURTHER MOVE that the CAO report back in the mid-year financial status report or sooner with the identification of any un-budgeted and un-allocated revenues that may be transferred and/or deposited on a one-time basis to the Serving and Housing LA's Homeless UB account;

I FURTHER MOVE that the CAO report back in the mid-year financial status report or sooner with the identification of existing appropriations within the FY 2015-16 Budget that the City Council and Mayor may consider to re-program and re-appropriate towards the Serving and Housing LA's Homeless UB account.
