Discussion and possible action of a great idea, presented by our Streets and Transportation Committee Chair Anthony Scearce, called Pedestrian Flags to make our streets safer for the School children. the program works simply by placing a bucket on each side of the street, Red Flags inside the buckets and when children need to cress the streets they will pick up a flag and hold up for the coming traffic to stop. the flags will make the children more visible to the coming traffic. Mr. Scearce noted that the project originated in NewJersey and is implemented by the help of the boys and girl scouts and that West Hills will be the first city to start this project. Committee members suggested that we need to have permits from the city to start this project and the approval of LAUSD. Tony will check with Eric Moody, from CD12 for the permit. With all the pandemic problems, talks about this project will not start until 2021. At which time we will pick up this idea and discuss with Tony and LAUSD officials.
