The WHNC Vice President shall Chair an Ad Hoc Vacancy Committee. In selecting the members for the committee, the Chair shall give first consideration to eligible Board members who express interest and who did not serve on the last previous Bylaws Ad Hoc Committee. To be considered eligible a Board member must be current in all required neighborhood council training.

 - 1. Shall maintain an inventory of all assets and properties of the WHNC.
 - 2. Shall conduct an audit of the budgeted expenditures of all committees monthly (review of the MER).
 - 3. Shall submit the audits to the board quarterly.
 - 4. Shall be a member co-chair of the Budget Committee.

Sample Proposed Standing Rule for Article 5, Section 5

All committees shall have self-written standing operating rules that shall include:

- A. Criteria for membership and voting in the committee
- B. Definition of what "serving actively on at least one committee" means for the committee
- C. Other rules of operation, if any

Add paragraph D. There shall be no limit on the number of board members for all Standing Committees.

Any board member in good standing may request membership if that member has attended at least three
(3) previous meetings of the committee.

Additional suggestion – Committee Chairs shall not deny committee membership to any Board member who requests to join the committee.

ARTICLE VI OFFICERS Section 1: Officers of the Board

The Officers of the Board shall include a President, Vice President, Secretary, Treasurer and Controller. The President may share duties of office with the Vice President. No individual may hold more than one Officer Position at the same time.

Example – <u>To be eligible for nomination for the Office of President of the WHNC Board of Directors a Board member must have been a member of the WHNC Board for two (2) years.</u>

Public comment is limited to 2 minutes per speaker, unless adjusted by the presiding officer of said committee.

- 6. Discussion and Possible Action to Add a Provision to the Ad Hoc Bylaws Committee Operating Rules Allowing Committee Chairs to remove Committee Members. 3. Members of this committee shall be appointed or removed by the Chair(s).
- 7. Add Committee Members with New Members Eligible to Vote Immediately: After discussion item was tabled.
- 8. Comments from the Chairs: Brad reiterated the proposed amendments in agenda items are not recommendations from the committee chairs but are recommendations from committee members, other Board members, and stakeholders. The committee chairs are opposed to some of the proposals.
- 9. Public Comment: None.
- 10. What Information should be Included in WHNC Board Meeting Minutes: Steve said comments from government and other organizations should be noted; but public comments should be summarized and not repeated, and should not include slanderous remarks. Char said DONE accepts complaints against NC Boards but immediately dismisses complaints that mention an individual Board member. Carolyn said that if public comments are included they should all be included but paraphrased and not quoted. As an example she said "made allegations against" can be used without going into detail. Carolyn also said she thinks minutes should include public comment. Saif said public comments should be noted briefly. Dan said the elimination of public comment from WHNC minutes caused more problems than it solved. As an example he said "so and so was criticized by {list of names}." Kent said there should be no mention of public comments in the minutes and the correctness of paraphrasing could be disputed. Brad reminded everyone there are two types of public comment; general public comment and public comment on agenda items; and asked everyone to specify which they are referring to when speaking. Myrl said there should be no general public comments noted in the minutes. Aida said it does not make the Board look good to put "soap opera" comments in the minutes. She cited penal code 403 and said the provision to lawfully remove anyone who willfully

disrupts a meeting should apply to minutes. Aida also suggested that for public comment a statement to check the video/film/tape could suffice. Anthony said maybe public comments should be included without Board member names. He also said he, with the help of others, has reviewed the recording where the decision was made to remove all comments and believes it applies only to the February Board meeting. Steve said he agrees summarization or paraphrasing could be a problem. He also said public comment needs to be included for agenda items. Brad cautioned practicing censorship is dangerous. Char said in the past comments were described in general terms and it worked fine. Dan said the First Amendment is a pillar of democracy and it is appropriate to paraphrase comments as long as everything is stated in neutral terms. Myrl said there is a difference between First Amendment speech and slander. He suggested "Public Comments were made on a variety of topics, the Board, and the community by {list of names} listen at ..." do not memorialize in print as anyone can use it anyway they want at anytime. Kent said First Amendment rights do not include any obligation to memorialize comments and doing so opens the Board up to exposure. Anthony said there should be no slander included in the minutes but the voices of stakeholders should not be muted. He also said the Board should not take legal advice from anyone other than the City Attorney. Anthony also said currently meeting recordings ore stored on Zoom and if Zoom goes away so do the recordings, therefore writing a policy making the recordings part of minutes entails risk. Brad reminded everyone the mandatory recording of Board meetings has a sunset and ends when the emergency resolution switching from in-person meetings to online meetings expires. Sandi asked that an amendment be put to a vote. Steve said anyone can download the Zoom recordings from the links and have their own copy. He suggested designating an individual to be responsible for doing this. Anthony said currently the recordings are not stored on a server the WHNC controls, and although DONE only requires recordings be kept for 30 days; this is not sufficient if they are to be part of the WHNC minutes. Aida said this issue can be resolved if we send the recordings to a location with permanent access. Faye asked if the recordings could be put on the WHNC website. Brad, as Chair of the Communications and Outreach Committee, asked Anthony if he would contact The Web Corner, WHNC website host, concerning the possibility of storing all recordings on the Rackspace server the WHNC documents are stored on. Anthony accepted the project to investigate the storage capacity WHNC has under contract with The Web Corner. Dan said the WHNC has been doing business for 20 years describing comments and never had a disaster or legal reckoning. He also said the public has a constitutional right to petition or address government. Saif said if Rackspace is too expensive maybe the WHNC could purchase inexpensive cloud space.

Steve moved to include general public comment in Board meeting minutes with the exception of potentially slanderous comments about individuals. Joan seconded.
