JOINT HOMELESSNESS COMMITTEE/BOARD MEETING MINUTES March 15, 2021 Telephonic and Web Meeting

Committee Co-chair Aida Abkarians called the meeting to order at 6:02PM. A quorum was established.

Chair Comments: No comments from the Chair

The February meeting minutes were approved, except discussion on Item 8 regarding "commandeering". To review video of mtg.

- 5. Report from Homeless Liaison Marie Javdani: The Liaison Office held a meeting to discuss election Outreach to homeless stakeholders. Marie also, reported, "I've passed the information along but have yet been informed when the public meeting with service providers will be."
- 6. Public Comment: "Olga", a resident near Shadow Ranch Park, reported homeless encampments at the North entrance of the park that negatively impacted the quality of her life and requested support. Several public comments were made opposed to a shelter that has not been proposed by this committee —David Ayala, Traci Lambert, Trudy Latif, "Cindy", Saurabh Pandit, "Jim", Tony Stotzer, Christine Rowe, "Annalisa", Anne Bauman, Lily Cohen, Andy Beltran, "Chloe, Dipti Naida, "Fern", "Satya", Albert Lin, Darna Van Der Valk from CNC and Josh Lustyan. Hannah Bowman stated support for housing and services in West Hills and stated, "that many of the statements from the opposed group were factually untrue and stigmatized our unhoused neighbors. Shervin Aazami stated his support of housing and services in West Hills, and stated, "police have not been defunded, LAPD funding is over one-third of the City Budget, due to the disproportionate percentage of people of color are represented in our homeless population that this amounts to racism, which is equal to NIMBYism, in essence." During the public comment item, board member Steve Randall, made accusations about election candidates he opposed in the upcoming WHNC election.

JOINT HOMELESSNESS COMMITTEE/BOARD MEETING MINUTES April 19, 2021

Telephonic and Web Meeting

Revised April 20, 2021

Attendance: Aida Abkarians, Thomas Booth, Olivia Naturman, Brian Begun, Tariq El-Atrache, Marie Javdani, Saif Mogri, Steve Randall, Myrl Schreibman, Joan Trent, and Brad Vanderhoof

Committee Co-chair Olivia Naturman called the meeting to order at 6:00 PM. A quorum was established.

Chair Comments:

Numbers refer to agenda items.

- 7. Report from Los Angeles Homeless Services Authority LAHSA representative: Olivia welcomed Brittnee Hill, Director of Access and Engagement, LASHA. Ms. Hill gave an introduction to LASHA. Her department provides outreach to individuals experiencing homelessness and records all contacts in the Coordinated Entry System. She described LA-HOP, an online portal for the public to request outreach services for unhoused individuals they encounter. Minors and families with children should be reported to 211, the LA County non-emergency phone number. Mental health emergencies should be reported to 911. LA-HOP response time is typically 2-5 days.
- 4. Comments from the Co-Chairs: Thomas mentioned Kian Gholibeik has resigned as a stakeholder committee member due to school commitments. He hopes to rejoin the committee in the summer.
- 6. Public Comment: Joellen asked if anyone is checking unhoused individuals encamped at Shadow ranch Park for penal code 390, sexual abuse, convictions. Chris Rowe said she has checked the Megan's Law website and found there are registered offenders living close to Hamlin Street Elementary School, and Shadow Ranch Park; in violation of the law.
- 5. Report from Homeless Liaison, Marie Javdani, WHNC: The liaisons have not met. Marie has delivered NC ballot applications to the West Valley Food Pantry and Olivia verified they are being distributed.
- 8. Presentation on Food Waste: Brian Begun presented his idea to collect excess food supplies from businesses to help those who are food insecure. 5.5 million tons of food are wasted annually in California. He suggested the WHNC collect information on food storage capacity in the West Valley and then connect service providers to sources of food that is otherwise wasted.
- 9. Committee Name Change: Marie has suggested changing the committee name to something more inclusive and descriptive. Several additions were mentioned including; Housing, Poverty, Services, and Support. The item was tabled to May.
- 12. West Hills NC Task Force on Shelter, Housing or Safe Parking options: Olivia reported there were three tents at Shadow Ranch Park the previous week but only one when the meeting agenda was posted so the number fluctuates. Thomas said the goal of the task force is to address immediate needs and get people off the street faster. There is no plan or specific strategy concerning Shadow Ranch Park.

The meeting ended due to time constraints.
