### **JOINT COMMUNITY/SENIOR CENTER AD HOC COMMITTEE/BOARD MEETING DRAFT MINUTES Tuesday March 15, 2016 West Hills Hospital, West Hills**

The meeting was called to order at 7:32 PM by Steve Randall, Chair

In attendance were Steve Randall, Char Rothstein, Dan Brin, Aida Abkarians, Ron Sobel, Reeyan Raynes, Marge Brown, Thomas Booth, Jacquie Young, Ed Young, Brad Vanderhoof, Mary Crescenzo and Iris Pucter(?). A quorum was established and the February 16, 2015 minutes were approved as amended.

Steve updated the committee on the Valley Circle site. Steve sent Timothy Lippman a plot plan and floor plan that was passed along to the Dept of Public Works. The DPW is planning to use that property for the community and said that they would keep the Community/Senior Center in mind when deciding its use. Steve will contact Regional Planning.

Ed said he would contact Sheila Kuehl and try to get an appointment to discuss the Community/Senior Center. Aida attempted to contact Fallbrook Center, with no response. Steve had Bill Rose check on Fallbrook Center space, who found that they wanted very high rent. Tom agreed to email to Steve Randall his letter to Corporate Point and work with him on a letter to all officials. Use of the Community Center in Westfield came up, but this location is outside of West Hills and not usable for meetings. Another site mentioned was the DWP property at the north end of Fallbrook. Recent developments may reopen the possibility of a wetlands project at Lederer and space for a Community Center. Reeyan agreed to contact Orcutt Ranch to see about WHNC meetings.

Mary requested that Patrick Young attend a meeting to speak on building a Community Center. Ed felt this was outside of Patrick's realm. Mary also mentioned that she attended a meeting on senior program for independent seniors. Marge Brown has also been working independently on a seniors "Young at Heart" program. Marge plans to have a signup sheet at the Eggstravaganza on March 19<sup>th</sup>. Marge & Ed would like to see a senior event in West Hills to introduce our Community/Senior Center concept. Reeyan suggested that this could be done as a "Meet & Greet" event for all Community stakeholders.

Aida & Marge asked that committee members bring ideas for community events to our next meeting. It was suggested that a restaurant could be a good venue for an event.

Aida submitted two more signed petition pages.

Steve announced that our next meeting is scheduled for Tuesday, April 16, 2016 at 7:30 PM at West Hills Hospital.
