Public comment is limited to 2 minutes per speaker, unless adjusted by the presiding officer of said committee.

Webinar and Telephonic Meeting

Co-Chair Steve Randall called the meeting to order at 7:02 PM and a quorum was established.

The minutes from the May 12, 2021 meeting were approved.

Comments from the Co Chairs: Steve and Alec did not have any comments.

Saif Mogri made a presentation concerning the 2020 heat wave in Los Angeles and concluded that climate change had overrun the energy suppliers' plans and need emergency rules such as limited A/C and clothes dryers. The demand response was good, and improvements have been made for forecasting.

Alec opened a discussion on DWP efforts and members suggested a larger audience, understanding of power bills and how to reduce these charges, as well as working with other neighborhood councils for forums to inform the public.

Steve adjourned the meeting at 8:40 PM.
