### JOINT BOARD AND ENVIRONMENT COMMITTEE MEETING MINUTES

April 13, 2022

Webinar and Telephonic Meeting

Co-Chair Steve Randall called the meeting to order at 7:05 PM and a quorum was established.

Committee members in attendance: Steve Randall, Alec Uzemeck, Charline Rothstein, Faye Barta, Saif Mogri, Rosi Mariconda and Jack Feldman.

Other Attendees: John Luker, Glen Jennings, Christina Walsh, Chris Rowe and Bonnie Klea

The minutes from the March 9, 2022 meeting were approved.

Comments from the Co- Chairs: Steve and Alec did not have any comments.

Alec introduced John Luker, who spoke about the DTSC delaying the Sage Ranch cleanup by 5 years, and stated that Hirsch at the Water Board hearing was asking for more stringent standards before the water permit renewal. John stated that the DTSC recently approved the Sage Ranch cleanup, and that he felt that the court activity would delay the full cleanup by 10 years. John also stated that the costs for cleanup to background would require many millions of dollars for the SSFL and that it is unlikely that congress would allocate the funds.

Char raised the question of why the folks asking for a radical cleanup at the SSFL continue to live in West Hills when they say is a destination of SSFL contamination?

During Public Comments, Christina Walsh spoke about the shortage of potable water in a northern California community, the cleanup at Sage Ranch and the delays of the SSFL cleanup created by the DTSC and Hirsch groups, as well as the numerous shooting ranges at the SSFL.

Chris Rowe spoke about the lack of sustainability on earth for water and food. She stated that she attended the Water Board meeting. She mentioned the rising lead levels in the SSFL runoff and a reminder of the Chumash cultural interests in the SSFL land. She also spoke about the SSFL cleanup delays caused by Hirsch lawsuits over the past 10 years.

Steve adjourned the meeting at 8:28 PM.
