If there are any broadcasting interruptions that prevent the public from observing or hearing the meeting, the meeting must be recessed or adjourned. If members of the public are unable to provide public comment or be heard due to issues within the Neighborhood Council's control, the meeting must be recessed or adjourned.

Comments from the public on agenda items will be heard only when the respective item is being considered. Comments from the public on matters not appearing on the agenda that are within the committee's jurisdiction will be heard during the General Public Comment period. Please note that under the Ralph M. Brown Act, the committee is prevented from acting on a matter that you bring to its attention during the General Public Comment period; however, the issue raised by a member of the public may become the subject of a future committee meeting. Public comment is limited to 2 minutes per speaker, unless adjusted by the presiding officer of said committee.

Notice to Paid Representatives: If you are compensated to monitor, attend, or speak at this meeting, City law may require you to register as a lobbyist and report your activity. “SPECIAL” JOINT SPECIAL EVENTS COMMITTEE/BOARD MEETING MINUTES Tuesday, July 19, 2022 @ 7:30 P.M.

This meeting of the Special Events Committee was conducted online via Zoom webinar and Telephonically.

Committee Co-Chair Steve Randall called the meeting to order at 7:36 P.M.

Committee members in attendance were: Steve Randall (Co-Chair), Myrl Schreiber (Co-Chair), Char Rothstein, Dr. Faye Barta, Aida Abkarians, Glenn Jennings, Clarice Chavira, Joan Trent and Saif Mogri. Others in attendance were Brad Vanderhoof and Mihran Kalaydjian. A quorum was established.

The May 3, 2022 minutes were approved as amended.

There were no Comments from the Chair(s)

Mihran Kalaydjian spoke about having the WHNC co-host a virtual mayoral candidate forum with the Woodland Hills NC. Mihran stated that both candidates have agreed to attend. Steve stated that West Hills has hosted these forums in the past and that they were very successful. Mihran stated that there would be no cost to the NCs, that DONE would pay for any expenses, that he would promote the event and would expect in excess of 1,000 attendees.

Myrl requested that Mihran provide details in writing so we could present to the board. Mihran complimented Myrl for his letter presented to the Homelessness Committee the previous day, how that committee operated, and also stated that he was impressed with Steve's emails regarding various issues. Char asked about the date and who the moderator(s) would be. Mihran stated 30-60 days from now and that the moderators would not charge. Mihran said he would send all the information to Steve, Myrl and Char. Steve called for a vote on participating with the forum and it passed unanimously.

Myrl spoke about the 4th Annual Halloween Houses on Display event with judging on Saturday and Sunday October 22nd and 23rd and public viewing from October 25th to October 31st. This year the application deadline would be October 19th and lawn signs would identify the winners. Saif left the meeting at 8:17 PM. Steve called for a roll call vote to approve and it passed unanimously with Rosie & Saif absent. Steve and Myrl thanked everyone.

There were no public comments.

The next regular Special Events Committee meeting is scheduled for Tuesday, August 2, 2022 at 7:00 P.M.

The meeting was adjourned by Steve Randall at 8:20 P.M.
