Public comment is limited to 2 minutes per speaker, unless adjusted by the presiding officer of said committee.

**Notice to Paid Representatives:** If you are compensated to monitor, attend, or speak at this meeting, City law may require you to register as a lobbyist and report your activity. ### JOINT SPECIAL EVENTS COMMITTEE/BOARD MEETING MINUTES

**Wednesday, September 7, 2022 @ 7:00 P.M.**

This meeting of the Special Events Committee was conducted online via Zoom webinar and Telephonically.

The August 2, 2022 minutes were approved as amended.

Comments from the Chair(s): Myrl Schreibman advised that we are on our way to promoting our upcoming events.

The 2023 Senior's Valentine's Day Dinner Dance was discussed and Myrl stated that we need to decide on a date and venue. Char agreed to check on the availability of the Bob Hope Center at Chaminade, De Toledo High School, and Shomrei Torah Synagogue as possible venues. Currently, the event date is February 14<sup>th</sup>.

The 2022 Halloween Event was discussed. Myrl informed that the printing of 500 flyers with an application on the reverse are in the works. In addition, 2 large posters and 8/11"x17" store window signs are being printed. Myrl asked that committee members suggest stores for the window signs. Myrl advised that there would be eight awards presented this year. They are 1) The Scariest, 2) Most Comical, 3) Most Innovative, 4) Most Inventive, 5) Best Interactive, 6) Best Animation, 7) Best Thematic, and 8) CD12 Councilman's Award. Saif agreed to inquire on the cost for the eight winner's lawn signs.

A discussion followed regarding what should be given to all entrants. We were thinking to find something other than the WHNC Mugs we have used in the past. Steve suggested using the mugs as pots with a plant in it. Aida suggested a reusable water bottle with the WHNC logo and West Hills Halloween Houses on Display printed on it.

Myrl stated that he would work on the details for each category.

There were no Public Comments as no members of the public were in attendance.
