If members of the public are unable to provide public comment or be heard due to issues within the Neighborhood Council's control, the meeting must be recessed or adjourned.

Public comment is limited to 2 minutes per speaker, unless adjusted by the presiding officer of said committee.

**Notice to Paid Representatives:** If you are compensated to monitor, attend, or speak at this meeting, City law may require you to register as a lobbyist and report your activity. ### JOINT SPECIAL EVENTS COMMITTEE/BOARD MEETING MINUTES

**Wednesday, October 10, 2022 @ 7:00 P.M.**

This meeting of the Special Events Committee was conducted online via Zoom webinar and Telephonically.

Committee Co-Chair Steve Randall called the meeting to order at 7:05 P.M.

Also in attendance were Brad Vanderhoof and Alejandro Phillips.

The September 7, 2022 minutes were approved as amended.

Comments from the Chair(s): Myrl Schreiber welcomed Alejandro to the meeting and explained the committee's three main annual events.

The 2023 Senior's Valentine's Day Dinner Dance was discussed. Char agreed to check on the availability of the Bob Hope Center at Chaminade, El Camino Shoup campus, and Shomrei Torah Synagogue as possible venues. Rosi offered to contact Calvary Church on Shoup as well as help in contacting other venues. Currently, the event date is February 14<sup>th</sup>, and Steve will confirm John Lee's availability that day. Faye Barta said that she would check on the availability of a band as an option to a DJ.

Myrl informed that we are at 25 applications for the 2022 Halloween Event, and that all judges have been confirmed. The judges and committee members are to meet at Myrl's home at 5:45 PM on Sunday October 23<sup>rd</sup>, and caravans will leave at 6:15 PM. Trial runs are anticipated. The list of various awards and their interpretations was discussed. The committee agreed that lawn signs for the award-winning houses was a good idea and they are being made and will go to Aida for the award names to be entered. Placing of the winner signs is planned for Monday morning, October 24<sup>th</sup>. Myrl is going to contact the media to try to get TV coverage. Myrl stated that we have a videographer for the night of the judging, but that we still need a good photographer. The drivers for the judges are Faye & Glen in one vehicle, Steve, and possibly Char and/or Aida. Alejandro suggested using GPS directions for both the judges and the public who wish to see the decorations.
