If there are any broadcasting interruptions that prevent the public from observing or hearing the meeting, the meeting must be recessed or adjourned. If members of the public are unable to provide public comment or be heard due to issues within the Neighborhood Council's control, the meeting must be recessed or adjourned.

Comments from the public on matters not appearing on the agenda that are within the committee's jurisdiction will be heard during the General Public Comment period. Please note that under the Ralph M. Brown Act, the committee is prevented from acting on a matter that you bring to its attention during the General Public Comment period; however, the issue raised by a member of the public may become the subject of a future committee meeting. Public comment is limited to 2 minutes per speaker, unless adjusted by the presiding officer of said committee.

Notice to Paid Representatives: If you are compensated to monitor, attend, or speak at this meeting, City law may require you to register as a lobbyist and report your activity. JOINT SPECIAL EVENTS COMMITTEE/BOARD MEETING MINUTES

Tuesday, January 3, 2023 @ 7:00 P.M.

This meeting of the Special Events Committee was conducted online via Zoom webinar and Telephonically.

Committee Co-Chair Steve Randall called the meeting to order at 7:18 P.M.

Committee members in attendance were: Steve Randall (Co-Chair), Myrl Schreiber (Co-Chair), Dr. Faye Barta, Aida Abkarians, Glenn Jennings, Joan Trent, Saif Mogri, Alejandro Phillips, and Rosi Mariconda. A quorum was established.

Also in attendance were Brad Vanderhoof and Kent Mariconda.

The December 6, 2022 minutes were approved as amended by unanimous consent.

Comments from the Chair(s): Myrl stated that we need to do things for the community and not ourselves. Maybe a small West Hills float for the Rose Parade. Place on February Agenda. Steve mentioned that the new Bulletin Board is installed at Platt Village, but that we need to continue to use the one at Shadow Ranch until the new location is approved.

During the discussion of the 2023 Senior Valentine's Day Dinner Dance, Steve mentioned that the Bob Hope Center at Chaminade location had still not been approved by the City. Myrl was confident that the City would approve a location and that we should move forward with obtaining raffle prizes and other details. Steve stated that John Lee is available for February 14th, but that in any event that we would do something for the seniors in 2023.

During the discussion of the 2023 Kids' Day Event, Myrl suggested that we move the event to May rather than March as was approved by committee in November. After much discussion, Myrl moved and Faye seconded to set the date as May 6th. The committee vote was unanimous in favor.

During the discussion of the 2023 Memorial Day Parade, it was decided that this committee need not get involved and to have Dan handle it as in the past. No action was taken.

The CD12 election candidate forum was discussed and no action taken.

There were no Public Comments.

The next regularly scheduled Special Events Committee meeting is on February 7, 2023.

The meeting was adjourned by Steve Randall at 8:11 P.M.
